City Manager Whitt requested City Attorney Vanerian to provide an update on a pending lawsuit, BDS vs. City of Walled Lake.

City Attorney Vanerian explained he received correspondence of an order from the Michigan Supreme Court denying BDS' leave to appeal. City Attorney Vanerian explained BDS was an applicant for medical marijuana, they were denied because they did not meet the criteria under the city ordinances. City Attorney Vanerian explained BDS filed a lawsuit in circuit court and the court issued a lengthy detailed written opinion on the case, ultimately concluding the city council properly denied the application. City Attorney Vanerian explained BDS then filed an appeal to Michigan Supreme Court challenging the circuit court's decision. City Attorney Vanerian explained the Michigan Supreme Court of Appeal denied the BDS appeal finding it to be meritless. City Attorney Vanerian explained BDS then appealed the denial of the Michigan Supreme Court. City Attorney Vanerian explained the Michigan Supreme Court ultimately denied that appeal as well. City Attorney Vanerian explained BDS has exhausted all of their appeal opportunities and they cannot appeal any further.
