2. First Amendment to Planned Unit Development Agreement for Forestbrook Apartments

City Attorney Vanerian explained the developer requested an amendment to the PUD agreement to address city engineering concerns of proposed trees and landscape amenities to proposed utilities in public right of ways. Attorney Vanerian said the city

engineering standards have recommendations as they relate to where things should be planted around utilities and right of ways. Attorney Vanerian said the developer's plan proposed placing landscaping closer to the utilities than the guidelines provide. Attorney Vanerian said the city engineer explained he did not have a problem with placement provided the developer is willing to assume the potential cost of having to place these amenities or if utility work needs to be done or if the trees cause any damage to the utilities, replacement cost is upon the developer. Attorney Vanerian said the developer would have to pay cost or reimburse the city.

Council Member Owsinek asked if this was reviewed for legal sufficiency.

City Attorney Vanerian said yes he drafted it.
