City Manager Whitt explained the Farmer's Market hosted its last venue for the season. City Manager Whitt requested Ms. Jaquays to share the video of the grand opening of the pedestrian bridge and trailhead. City Manager Whitt said thank you to Ms. Lori Whitt for recruiting volunteers and continuing the project with the Monarch butterfly sanctuary that will be instituted in the spring of next year near the pedestrian bridge. City Manager Whitt explained the Mercer Beach fencing has been placed and opined it changes the whole atmosphere down there. City Manager Whitt explained the home next to the beach was recently sold and the new owners are

cleaning up the site. City Manager Whitt explained there is more work with landscaping at the beach coming this year.

City Manager Whitt explained the stretch of Pontiac Trail in Walled Lake has been paved and striped. City Manager Whitt explained there were a lot of items accomplished this year and he is proud of that. City Manager Whitt explained Mrs. Pesta will be heading up the Tree Lighting Ceremony this year. The details are being worked out and the date is December 5, 2022. Walled Lake Northern and Walled Lake Western bands have confirmed their attendance. City Manager Whitt said the Parks and Recreation Commission Chairman Dennis O'Rourke will be chairing the tree lighting event. City Manager Whitt said there were reports of an unapproved event downtown this past weekend that was hosted by The Beach Tiki Bar and Boil. City Manager Whitt explained Walled Lake Police and Oakland County Sheriff were called there. City Manager Whitt explained there were instructions to arrest Tiki Bar personnel who caused this disturbance of the peace. City Manager Whitt said The Beach Tiki Bar and Boil personnel will be held accountable. City Manager Whitt said there were numerous phone calls and reports regarding this illegal event. City Manager Whitt said he also gave instruction to conduct investigations of reports that The Beach Tiki Bar and Boil employees were intoxicated while working and serving patrons.

Council Member Woods said he received calls from residents that the people driving by in their vehicles were throwing items at the surrounding neighbors who live downtown. Council Member Woods said he and Council Member Ambrose picked up two bags of trash after the event. Council Member Woods said this cannot happen. Council Member Woods said this action is not the way Walled Lake wants to move forward.

City Manager Whitt explained when there are events, they are reviewed to address public safety, staffing, and clean-up schedules. City Manager Whitt explained he is not opposed to having the council and the residents see what this restaurant caused and how bad a corporate neighbor The Beach Tiki Bar and Boil is to the city and its residents. City Manager Whitt explained there are multiple events throughout the year in the city and the applicants work with the city. City Manager Whitt explained The Beach Tiki Bar and Boil had no communication with the city about this event. City Manager Whitt explained with the use of social media, a flash mob is something that can occur and did occur. City Manager Whitt explained, however, the city will not clean up after the Tiki Bar every time they throw an impromptu event. City Manager Whitt explained city administration will review the legislation to prohibit these types of events. City Manager Whitt said he will pursue disturbance of the peace, and someone will be going to jail.

Council Member Ambrose said his family's restaurant has hosted car shows, there is significant planning involved. Council Member Ambrose said he personally cleans up after their car shows. Council Member Ambrose explained the lack of planning from party hosts is not fair to the people who live here and work here.

City Manager Whitt explained that The Beach Tiki Bar and Boil is not a good corporate neighbor, they do not participate, and do nothing but create more problems and push back.

Mayor Pro Tem Lublin explained there are many events within the city and there is organization and cooperation.

City Manager Whitt said with advanced notice, there can be extra people to address the squealing of tires and disturbing of the peace. City Manager Whitt said The Beach Tiki Bar and Boil caused this problem when they invite people down and have no communication with the city.

Council Member Fernandes said it was not a good event, cars were parked without permission in the yards of the people who live down there. Council Member Fernandes said she is glad our city administration and the police will bring this into order.

City Manager Whitt said it is not just this event, there are intoxicated employees serving patrons. City Manager Whitt said there are issues at The Beach Tiki Bar and Boil. City Manager Whitt explained all of this will be reviewed.

Council Member Ambrose said the Walled Lake Police Officers that were able to assist with no notice to address that chaos, thank you.
