NEW BUSINESS:

1. DDA Chairman Ambrose Report on Walled Lake Community Playhouse: Jewish Ensemble Theatre (JET) August Performance

DDA Chairman Ambrose said he met with DPW Team Lead Dan Ladd, City Manager Whitt, and Executive Director Chris Bremer at the Public Safety Campus to discuss the layout for the outdoor performance. Mr. Ambrose said they discussed lighting, parking, and strategic planning for the event.

JET Executive Director Chris Bremer expressed his thanks and gratitude for the City and DDA's support of the JET theatre. Mr. Bremer said he is excited to perform "Grease" on August 27th,

28th, and 29th. Mr. Bremer described the stage and layout of the event noting that there will be concessions available on-site. Mr. Bremer said postcards have been mailed out and there are extra available for distribution. Mr. Bremer said he is hopeful that this event will be a success.

DDA Executive Director Whitt said there are continued improvements happening at the Public Safety Campus. Mr. Whitt said there were errors to the ponds, so there is construction happening to remedy those errors.
