#### **COMMUNICATION:**

City Attorney Vanerian at last meeting of July the board rendered an interpretation of front yard setback pursuant to a written request of area resident Ms. Kelly Tome. Attorney Vanerian said the request originated from a proposed improvement of an existing home on E. Walled Lake Drive, neighboring Ms. Tome's property. Attorney Vanerian explained the owner Mr. Ben Berry following the boards interpretation at the July meeting, filed a circuit court action challenging the Zoning Board of Appeals interpretation of the setbacks. Attorney Vanerian explained the appropriate response has been prepared and filed on behalf of the city. Attorney Vanerian explained the parties have been briefed; the circuit court will be holding a hearing this week Wednesday for a court order requiring the building official to issue the building permit for renovation to his property. Attorney Vanerian explained the building official recently denied plans based on the board's interpretations. Attorney Vanerian said the building official advised the property owner of the interpretation. City attorney Vanerian explained it is up to the judge a final order or ruling.

This matter relates to property located at the above referenced location. The applicant is requesting variance from Article 20.08(e)(1) one wall sign shall be permitted per street frontage. Applicant is proposing two wall signs, an "M" and a "McDonald's" wordmark on the west elevation.

Consultant City Planner Jackson explained the applicant is proposing additional sign on the west elevation. He said the applicant has identified the size of the sign, a 14 square foot logo the golden arches and adding with the sign approved on the front of the building it still does not exceed the maximum sign allotment.

Consultant City Planner explained the other signs were not as they were approved during site plan with the Planning Commission.
